



Fraser Lands Church Camp/Conference Subsidy Fund Application Form

Guidelines:

- All FLC congregation-wide conferences/camps/retreats are eligible under this fund. Everyone is eligible to apply for a subsidy provided that:
 - The applicant has demonstrated his/her need for financial assistance.
 - The applicant must attend the conference/camp/retreat in accordance with the terms of the subsidy.
 - The applicant has not received financial assistance for another conference/camp/retreat within a calendar year. Volunteer helpers of Children and Teens camps who received fund subsidies are exempted from this requirement.
 - FLC conferences/camps/retreats that are not congregation-wide are not eligible. However, certain external conferences may be eligible for the subsidy subject to the approval of the Senior Pastor.
- Applicants may apply for up to 75% of conference fees to a maximum of \$200.
- For FLC congregation-wide conferences/camps/retreats and approved external conferences, fees must be prepaid in full. Applicants will be reimbursed for the approved applied for percentage of the fees when approval application process is complete
- Completed subsidy application forms must be submitted to the Congregation Pastor.
- Applications by minors (age 18 and below) must be co-signed by the parent/guardian.

When the application approval process is complete, applicants will be notified by the congregation pastor.
